

# MEMBERSHIP INFORMATION!

I have been reviewing our membership records and the methodology of recording important information pertaining to membership. I have found a couple glitches that should be an easy fix if I can get your help.

Membership in the GPR is on a yearly basis...January through December. We decided a few years ago to have all memberships come due in January so we would only have one major push to get all members current. If someone joined the club midyear we would prorate the dues to the following January and then that member would be caught up with everyone else and would have to pay the full annual dues in January.

In reviewing the membership roster I found several memberships were due in January '07 and have not been paid as of the first of July I. So, in order for you to check when your dues are payable, turn to the back page of this newsletter. Your will find the mailing label with your name and your membership expiration date next to your name. Just for fun check that right now.

All current and paid members will have an expiration date in '08. If you were a member last year, and your mailing label shows a date earlier that (07/07) you need to renew your membership and pay the \$30 dues. That will bring you current to January 2008. If you feel there is any discrepancy with your membership expiration date, please call me directly so we can work together to correct it.

A few members joined mid-2006 and their mailing label may indicate an expiration date other than 01/08. We will notify those members as their memberships expire and prorate the dues to the following January.

I also noticed a few members do not have a current "Hold Harmless Signature" on record. We must have a new "Hold Harmless Signature" sheet signed yearly when memberships are renewed. At the July meeting we will have a list of all members who do not have a current form on file. Please check the list when you sign in for the meeting. This will also give you an opportunity to confirm your mailing address and telephone numbers.

Rick Miska has included a Membership Application form with this newsletter. If you found that your membership is due, please take a moment to fill out the application form and mail it, along with your check, as soon as possible. You will find along the top of the application form a spot to check for renewal and another spot to check for "Hold Harmless Signature". Please check both boxes, fill in the required information about you, read and initial the "Hold Harmless Agreement", sign as primary member, and if you have a second family member/spouse have them sign on "Signature 2".

This form is the only way we have of keeping your membership records in order. From it we can have your correct mailing address for the newsletter. We will have current telephone numbers to use in the event we must cancel a meeting or other event. It is very important that we have this information.

I and the other Board Members appreciate your interest and participation in the GPR. However, unless memberships are renewed and "Hold Harmless Signature" forms are on file, we will have no choice but to cancel subscriptions to the Gold Nugget and deny access to club activities.

# Mini-sluice Method of Gold Cleanup by Allen Mershon, Transcribed by Paul Nagy

You've been working hard with suction dredge or sluice and now you've got one bodacious pile of black sands with a tidy sum of gold somewhere inside it. Now you're faced with panning and panning until you wished you'd never HEARD of gold panning. Is there an easier way of recovering the gold? You bet! Check out gold recovery pro Allen Mershon and his mini-sluice. Start with a three or four-foot piece of 3" diameter corrugated plastic drainpipe. Cut it lengthwise in half to form the chute of the sluice. The end of the sluice empties into a bucket. A small battery-powered electric motor (often a marine bilge pump) circulates the water. You can spoon-feed the black sands into the sluice, or as Larry Weilnau demonstrated, you can rig up a funnel which will also provide a continuous feed. (One good thing about this club is that you get good input from many knowledgable people).

You should first dry and then classify (sieve) your black sands to -40 mesh. Locally, you won't get much gold in the +40 fraction, but you can sluice this later, anyway. It's just that if the size variation in the feed is too great, then the sluice won't work as well. You should always dry the material out of doors and without the application of high heat. This is because there may be volatile and very toxic material in the black sand, such as mercury and tellurium and assorted man-made chemical substances which if roasted in a pan will VAPORIZE AND KILL YOU. And your children, pets, etc. If you insist on drying black sands

over a fire, at least do it alone so that you will be the only victim.

After you have sluiced some of your material, stop and pan the rejects from the bucket. This will tell you what you have missed. It will be a guide to adjusting the angle of the sluice, the water flow, or the size distribution of the feedstock. You should expect to sluice ALL of your material more than once. Which means drying all the rejects and sluicing them again, and maybe again. Mom Nature just doesn't give up her gold without a fight. But this is still easier, for most people, than panning through many pounds of black sands. This is still a strictly trial and error process, so don't get frustrated. Anyone else would have to do the same thing and the mini-sluice is doing the "heavy" work anyway.

The mechanics of gravity separation are so complex that a thousand Einsteins with a thousand mainframe computers could not produce an exact mathematical formula. Don't worry about it. You're not striving for theoretical precision, only practical application. See Allen Mershon or Larry Weilmau for questions of fine tuning. Good Luck!
