Anyway, that is how I see it from here. So until we meet again, keep your sunny sides up and may the bottoms of your pans turn bright with that 'Yaller Gold'..!



The V.P. Corner by Don Bray As a person

interested in mining activities, I don't have to stress the importance our access to the Public Lands owned by the federal government. This column is the second in a series of columns dealing with issues around our use of these, <u>our Public Lands</u>. The first column in this series appeared in the June issue of "The Golden Nugget"

Survey Systems Used on the Public Lands

The U.S. uses two major but different land survey systems depending on what state you are working in. The original and historic system is referred to as the "Metes and Bounds Survey





System" (pronounced: meats and bounds) and was inherited from the Colonial English. It was used in the original thirteen colonies and their western extensions (WV, KY and TN) and continued to be used by the fledgling U.S. Government up until the passage of the "1785 Land Ordinance". The founding fathers (many land surveyors themselves) recognized how cumbersome and inadequate their existing system was. The "1785 Land Ordinance" was their first attempt to replace the "Metes and Bounds Survey System" (M&B) with a more uniform and rectangular (logical) survey system. This new system established many survey concepts that were later to be used and improved upon in their "Public Lands Survey System" or PLSS, circa 1800, which is still in use today. In this article we shall discuss the M&B survey system. Today there are twenty states that still use the M&B system. These states are: Connecticut, Delaware, Georgia, Hawaii, Kentucky, Maine, Maryland, Massachusetts, New Hampshire, New Jersey, New York, North Carolina, Pennsylvania, Rhode Island, South Carolina, Tennessee, Texas, Vermont, Virginia, and West Virginia. The remaining thirty, generally western, states all use the newer "Public Lands Survey System". The main difference between the two systems is that while the PLSS system defines land parcels as generally rectangular and uniform in size and subdivision while with M&B the land parcels are of irregular shape and sizes, "they are what they are."

The Metes and Bounds Survey System

The term "mete" means to measure or allocate (as in: to mete out punishment), the term "bounds" refers to defining or establishing boundaries (as in: property boundaries). The Old English system of M&B worked well for their conditions: where survey instruments were crude, trained surveyors were few or non-existent, property parcels were small and tightly bounded by existing properties. The English/colonial survey system utilized visible permanent or semi-permanent geographic ground features for property boundary descriptions used in land title documents. These worked well in small tight communities were every one was local and could easily observe the features first hand and where property boundary knowledge could easily pass from generation to generation. However the system falls short when you consider sale and ownership by individuals and companies at long distances, such as across the Atlantic. For an example of M&B survey see the illustration titled "The Colonial Land Survey Method."

As survey instruments, tools and techniques have improved so have the methods of land descriptions.

Modern metes & bounds surveys and property descriptions no longer rely on geographic ground features but instead rely on "course and call statements" to define the property boundary lines. A course is a statement of angular direction expressed in degrees, minutes and seconds. All course statements begin with North/South directional and end and with an East/West directional (such as: S 13 Deg. 29' 44" W). A course statement is defined as 90 Deg. or less. A call is a statement of distance most often in feet but may also be in rods or chains. A boundary line is defined as a course followed by a call (such as: S 13 Deg. 29' 44" W, 447 feet).

There are two critical elements required when using M&B surveys and land descriptions. First, the "Point of Beginning" must be clearly identified and defined. Second, the boundary descriptive elements must "close."

Today metes and bounds are used in the twenty states, listed above, but also to define small land parcels in the PLSS (western states) such as your home's lot here in Colorado. In the PLSS states on public lands all "lode claims" and many "placer claims" are defined by M&B land descriptions.

- 2. Jim led the membership in the Pledge of Allegiance, to open the meeting.
- 3. Jim introduced GPR member Greg Davis as the presenter of tonight's program. Greg also presented last month's program on using Local County Online GIS Resources, available on the Internet, for land ownership research. Greg's program, tonight, consisted of an introduction to his California placer gold claim. The claim is on BLM land and has been known as the "Red Dog Placer Mine" since "forty-niner" days. The Red Dog is referenced in the short story titled The Luck of Roaring Camp by Bret Harte, in a derogatory context. The Red Dog is located on the South Fork of the Mokelumne River in Calaveras County, CA near the well known "Roaring Camp" a dude ranch for gold miners.
 - Greg explained how he used the techniques presented in his program last month, to find and research the land ownership in CA while living in Honolulu, HI.
 - Greg showed several pictures of the claim, the river with granite boulders and the access to the claim.
 - Greg then invited the entire GPR membership to "The First Annual Red Dog GPR Outing" at the Red
 - Dog claim the first week in September. Greg said that if you can attend, you can meet up with him any morning that week between 8:00 and 9:00 A.M. in Frank's Café in Mokelumne Hill at the junction of CA highways 26 and 49.
 - A good read on the history of the area is John Doble's Journals and Letters from the Mines.
 - Thanks Greg for another of your programs, well done.
- 4. Jim announced that today's metal prices were as follows: Gold \$1790.30 per t oz, Silver \$40.29 per t oz, Platinum \$1844.00 per t oz. and Palladium \$783.00 per t oz.
- 5. Jim announced that this month's website hits total 1172 since the last meeting.
- 6. Jim introduced Bill Chapman of Golden Detectors in Golden, who was in the audience this evening. Bill announced that he had, as of July 1st, sold the business to Louise Smith, his assistant at the store for the last 7 years. Bill then introduced Louise, also in attendance tonight.
- 7. Jim advised the membership that the owner of most of the property along North Clear Creek, between the Treatment Plant and the town of Blackhawk, has posted the area with "no trespassing" signs. The only open area to work there is the "Grubstaker" claim, be careful and know where you are working.

Jim said that they feel that they are about a year away from receiving their permits and plan to be in operation in 2012 or 2013. This will give us small miners a place to get our small quantities of metal containing ores smelted.
- 9. Jim announced that according to Peg Brozek's Board Meeting Treasurer's Report the club's finances remain in the black. He stated that the club still needs to purchase a little more gold to get through the end of the year. The finances should remain in the black even after that purchase.
- 10. Jim asks, membership chairman, Greg Davis for his membership report. Greg reported that tonight, we have 101 paid memberships plus 3 new memberships tonight and 71 in attendance including 8 guests. Greg also stated that he would be refunding \$15.00 to some recent new members because they paid a full year's dues in lieu of the required half year's dues due this time of the year.

President Long Conducts Panning/Sluicing Class

On Saturday August 27, President JJ Long hosted another beginners Panning/sluicing Class for newer Club members and prospective members. The Class was well attended by some 18 folks interested in learning the proper techniques for panning and sluicing for gold. The class was conducted in lower Clear Creek at 69th and N. Washington in unincorporated Adams County behind Tymkovich's Meat Market.

The attendees learned how to 'read' a watershed and then how to prepare a gold pan for service, then how to screen your material to make it more manageable. A tub of material was then provided for everyone to practice their panning. A number of the participants were quite surprised to find small pieces of gold in their pans. We even found small garnets which were quite a hit as well.

We then learned how to set up a sluice box and get the right 'drop' for the most efficient water flow and velocity and we ran a little material through the sluice and everyone got to see a little gold show up in the black mat.

All in all, everyone was quite pleased with the demonstration and everyone learned a lot. When I left, there were still a few people working in the creek. Remember to patronize the Tymkovich Meat Market as a thank you to those folks for allowing us the access to the Creek from their business.

Lebanon Silver Mine

The tour is a walking tour, located at the halfway point on the railroad. The tour takes you 500 feet into a mine tunnel bored in the 1870s. Your guide will point out rich veins of silver and tell you about early-day mining. The mine is usually relatively dry and a constant 44° F. The tour also includes visits to the manager's office, the miners change room and the tool shed. Hard Hats are provided. Please wear warm clothing and sturdy walking shoes. Bring your cameras!





Club Picnic a Big Success by Jim Long


The Annual Club Picnic was held on August 20 at 11am at the Lions Park in Golden, Colorado. About 45 to 50 members turned out for the event.


It was great seeing everyone at the picnic and I hope everyone had as good a time as I did.


