The V.P. Corner by Don Bray

The Colorado Commercial Mining Industry is about to double in size. Since the closures of the Climax Mine (Molybdenum) in 1982 and the Black Cloud Mine (Silver-Lead-Zinc) in 1999 Colorado has had only two operating commercially operating metals mines, the Henderson Mine (Molybdenum) and the Cripple Creek and Victor Mine (Gold). It looks very likely that two more commercial mines may soon begin operations.

First, Freeport-McMoRan, owners of the Henderson and Climax Mines, has spent \$450 million in preparing the Climax Mine for re-opening. If you drove into Leadville this summer, you saw large billboards advertising that Freeport-McMoRan is hiring for the Climax Mine operations. It is projected that when the mine goes into operation it will

employ about 385 people. The new construction is nearly completed and the only hold up to production is the depressed price of molybdenum. The price of molybdenum oxide was at \$35.00 per pound in Dec 2007, sunk to \$8.00 in April 2009 and today is at \$13.50. When the price reaches the right level the mine will begin production. With the \$450 million investment it appears that Freeport serious about starting production.

Secondly, Hecla Mining Co. has announced, on their website, their intention to resume mining for silver and gold in the Creede Mining District. Hecla, headquartered in Coeur d'Alene, ID, in Feb. 2008 formed a joint venture with partners Emerald Mining and Leasing, LLC and Golden 8 Mining, LLC holders of approximately 25 square mile of the patented and unpatented claims in the Creede Mining District. The joint venture is named San Juan Silver and is in the process of exploration via an extensive core-drilling program. From their website "San Juan Silver has received approval of its Environmental Assessment and 5-Year Plan of Operation in mid-2010, enabling aggressive expansion of exploration on three vein systems: Bulldog, Amethyst and Equity."

Also from the Hecla website "The San Juan Silver JV is the first entity to control the bulk of the famous Creede District in Colorado which has historic production of 84 million ounces of silver. Drilling and underground sampling along the past-producing Bulldog has defined at least 40 million ounces of silver and continues to intersect ore grade mineralization to the north along a one-mile trend. Where the Amethyst vein intersects the Equity structure, drilling has intersected a broad zone with multistage veins and breccias with zones of sulfides containing gold, silver, and base metals. High-grade gold and silver intersected in the veins are very significant as this is the deepest precious metal intercept of a major vein structure to date in the northern part of the district. These intersections are well below the historically perceived bottom of the precious metal horizon in the Creede District indicating a large vertical dimension of 2,000 feet, for gold-bearing mineralization. The mineralization is also open along strike and may extend for a significant distance along the Amethyst and the Equity structures. In addition, newly defined areas to the west of the Equity vein system encompass a broad gold-enriched surface anomaly cut by strong veining which will be followed up with more detailed exploration during 2011."

When these two projects progress to fruition and Colorado has four active metals mining operations perhaps the general public's jaundiced perception of mining activities will be replaced with excitement over the new jobs leading to easier permitting of more projects with jobs.


Ken Barker Award by Joe Shubert

General Meeting Minutes From Oct 2011

- 1) Vice President Don Bray called the meeting to order at 7:05 P.M.
- 2) Don Tiglas led the membership in the Pledge of Allegiance, to open the meeting.
- 3) Don Bray introduced GPR member Joe Fortunato the presenter of tonight's program. Joe apologized for not having the previously announced program on his summer Alaska field trip available. Instead Joe introduced a video presentation titled "Weekend Prospector" by Charles Garrett of Garrett Metal Detectors. Also in the video with Garrett were Roy Lagal, Virgil Hutton and Tommy Lund. The theme of the video is to show the prospective prospector the basics of weekend prospecting.

Highlights from the video were as follows:

- They recommend that you confine your prospecting to known gold locations.
- They outlined a list of recommended tools including a lightweight backpack dredge.
- They suggest streams with good gold replenishment can be worked year after year.
- They showed where to prospect in streams (such as downstream of large boulders etc.).
- They demonstrated wet panning.
- They demonstrated suction dredge operations and cleanup while recommending a 2" to 4" lightweight backpack dredge for the weekend prospector.
- The last segment we watched demonstrated nugget hunting with a metal detector.

Thanks Joe for bringing us this informative program.


- 4) Don announced that tonight, president Jim Long is out chasing Bambi somewhere, and that he as vice president will be conducting tonight's meeting.
- 5) Don announced that today's metal prices, at the New York close on Kitco, were as follows: Gold \$1642.70 per t oz, Silver \$30.82 per t oz, Platinum \$1513.00 per t oz. and Palladium \$602.00 per t oz.
- 6) Don announced that this month's website hits total is unavailable because the website is down and we can not get access to it. Andy is working on this problem.
- 7) Don called on Joe Schubert to announce that nominations are open for the November elections. Joe announced that it is time to be thinking about club elections again. Prospecting Instructional Class for JeffCo Open Space Rangers by Jim Long

On October 6, the Club hosted an instructional field demonstration of prospecting for the Jefferson County Open Spaces Rangers on Clear Creek. There were 12 enforcement officers who met up with Club President JJ Long at the Mexican Flats location on Clear Creek in Clear Creek Canyon Park.

We had set up several 'prospecting stations' to demonstrate panning, classifying, using a 'rocker box', battery operated wheels, sluice boxes, motorized high bankers and motorized dredges. Some of the stations were set up properly and others were deliberately set up incorrectly. The purpose of the Class was to instruct the Rangers on basic prospecting history and demonstrate methods and techniques. Special attention was shown to how the equipment should be set up and how and where to look for problems and incorrect and even illegal set ups.

The Rangers learned to identify what they were seeing and how to determine if the equipments were being used properly or improperly. There were some great questions asked and answered and the Class which lasted about 3 hours, was a big hit. Supervisor Colleen Gad provided us with a great box lunch and drinks as well. During the demonstrations, we actually found some gold which excited the Rangers a great deal.

My personal thanks go to Brandon Luchtenburg, Gary Hawley, Andy Doll, Mike Hurtado, and Steve Overton for taking the time to participate and for providing equipment to use and display. Several photos were taken by Colleen Gadd and shared with the Club.






