That is why I donate what I can to the PLP. It is why I have a membership to the GPAA, the ICMJ, PLP and others. I can't be there to help in person because these places are too often far away. But they could be on Clear Creek next week, or the Arkansas, or the Poudre next month. But I can support them by sending what I can afford. That is helping the best way that I can. And being informed is being fore warned. I hope all of you will join me and do all that you can to help in any little way that you can. Take out a membership, send in twenty bucks, do what you can, but do something. If we don't, we will have no complaint and no excuse. We just have to or all will be lost..!!

And that is the view from here and I wish you all Good Luck in your search! And until we meet again, keep your sunny sides up and may the bottoms of your pans turn bright with that treasured 'Yaller Gold'!

COLORADO TALES OF LOST TREASURE

How many times have you dreamed of finding a lost treasure? If you are like the rest of us it has surfaced to your conscious mind more than once. With that said let's talk about one of my favorite lost treasures, Dutch Oven Gold Dust Cache.

How many of you have been to Grand Lake which is approximately 60 miles northwest of Denver. Have you ever been boating, fishing, or camping at Grand Lake Reservoir? If you have you may know of the legend of lost treasures, if you haven't I will give you a reason to go sometime.

It is believed that the north shore of the lake hold a great treasure. There is said to be one very large Dutch oven filled

with one hundred pounds of gold dust. It has lain in this location for about one hundred and fifty years.

The oven it seems eludes all who search for it but for one young girl. As lore goes it was the spring of 1854 and six friends who had great success in the gold fields of California were planning their return to Virginia. They had worked hard, lived well for over three years, and accumulated one hundred pounds of gold nuggets and dusts. But as people do they missed their family and friends and were excited to be returning home.

Heading east from California with their cache, they were attacked by Indians near Steamboat. Two of the six were killed. The remaining men, outnumbered, began running from the Indians and found themselves at Grand Lake. You must realize this lake is approximately twelve miles long and on mile wide. The men followed, it is believed, a trail that wound around the northern part of the lake.

After spending the night at this spot the men were packing in the morning to leave. It was agreed by the four remaining partners to leave the heavier equipment as well as place all the gold nuggets and dust into a very large cast iron Dutch oven.

They dug a hole large enough to hold the Dutch oven and placed it in the hole. They then placed all the gold inside replaced the lid and covered the hole with dirt. They realized they needed to mark the location better and one of the men pulled his hunting knife out and jabbed it into a spruce tree adjacent to a number of large boulders. They all made mental notes of this area and headed toward home.

Their travels east were uneventful until they were almost home. Over the horizon were family and friends unaware the men were about to be attacked by Indians for a second time. Many months later the lone survivor of the six friends made his way home but the deaths of his friends and the very long journey had taken its toll.

The lone survivor told his story many times. Although he had come home a broken man he never forgot what they had buried at that lake. He passed his story to his children who came west looking for their fathers lost treasure. But they always went home empty handed.

In 1888 a trapper was camped along the northern shore and he spotted a knife sticking in a spruce tree several yards from his tent. Although it was rusty he tried to pull it out but he couldn't so he left it. In 1901 a young man and his girlfriend went for a walk as their friends were having a picnic. They came upon a spruce tree with a knife deeply impaled in the trunk. After several attempts to remove the knife they decided to leave it. In 1925 a fisherman found the handle of a knife protruding from the trunk of a spruce tree along the north shore.

Now back to our young girl. In the mid 1950's a family was camping up at the northern shore of the lake. On their second day the eleven year old daughter went for a walk and came back with the lid of a Dutch oven. Because her parents did not know the legend of treasure buried at the lake they did not investigate. Who knows what they may have found if they had only taken the time to look.

So now that I have your attention let me give you a few more treasure tales to look up.

Prospecting/Mining Notes

10-30-14 **Coal Mine Production cut back after Terminations:** Bowie Resource Partners LLC announced Wednesday that it will scale back production at the Bowie #2 Mine near Paonia, Colorado, after the Tennessee Valley Authority terminated its coals supply agreement with the company and continued weakness in coal demand. This has forced Bowie #2 to eliminate 150 jobs.

11-14-14 **Ex-CEO Indicted in Fatal Mine Blast:** The former CEO who oversaw the Upper Big Branch Mine in West Virginia that exploded in 2010, killing 29 people, was indicted Thursday on federal charges related to a safety investigation that followed the blast. Don Blankenship is accused of conspiracy to violate safety and health standards, impeding federal mine safety officials and making false statements to the Securities and Exchange Commission.

11-14-14 **Newmont Makes Big Gain on Gold:** Newmont Mining of Greenwood Village had the largest gain of any stock in the Standard & Poor's 500 Index Friday, rising 4.99% on higher gold prices. Gold futures have enjoyed their strongest 2 day gain since June, and spot gold rose 2.26% on Friday. Other Colorado gold companies with good gains included Royal Gold, up 5.1% and Vista Gold, up 8.3%.

11-19-14 **Oregon Firm Must Stop Selling Gold Mine Investments:** Securities Officials on Tuesday ordered a Bend, Oregon company to stop selling shares of a Nevada gold mining operation in Colorado. Big Spring Gold sold investment shares to two Colorado residents in 2012 and 2013 without the proper licenses. The Colorado investors paid \$31,000.




Want to go to Nome, Alaska..?


