## The Prez Sez by Jim Long



I am thoroughly disgusted..!! The Environmental Protective Agency (EPA) has contributed directly to the largest mine waste spill in recent Colorado history. This spill far exceeds the spill near Parachute 2 years ago of benzene by the oil drilling industry into the watershed. This spill is of such gigantic proportions that we may never know the full impact on the environment and the Animas River watershed for years to come.

The waste plume turned the Animas River a bright orange for miles as it worked its way south into the San Juan River and then west from New Mexico into Utah where it appears destined for Lake Powell.

"We are truly sorry for this incident and we accept full responsibility for it", said EPA spokes persons. Really?? The federal governmental agency charged with ensuring that such accidents don't happen and with cleaning up old abandoned mines, are the ones who screwed things up. The sludge that turned the river orange has caused damage that is hard to fully grasp. People whose livelihoods depend on the river have been left with nothing. Cities have had to shut down intake valves to avoid getting anything into their drinking water. Rafting businesses have lost income and revenue. Fishermen cannot fish. People are being warned to stay out of the water. And a week later, the head of the EPA and the Governor of Colorado finally manage to get to the scene of the crime as the water begins to clear and proclaim that while it looks bad, only time will tell what the real damage is. And they say they are sorry?

Mark my words...when the dust settles and the sludge clears, somehow, the EPA will shift the blame to miners for creating the situation in the first place. True, while mining practices of the past were less than concerning for the environment, miners of today were not responsible for it. Those mines were not dug by small scale miners. They were dug by the larger companies and corporations. Yet this black eye will follow modern miners and will have an impact on those of us who may desire to pursue a hard rock mine perhaps in the future. There are tens of thousands of old abandoned mines in the western United States, a great many of them in Colorado. A lot of them are just like the Gold King Mine near Silverton, the scene of the crime of this latest disaster. And it is estimated that the current oil drilling experiences an average of 2 spills per day..!! But the EPA has threatened anyone who tries to clean them up with arrest and fines because it is considered that none of us know how to do it right and only they do. What?? So when they screw things up and cause the problem, a simple apology will suffice? All I have to say is heads had better roll. Somebody needs to be held accountable. Sadly, the little guy worker who actually caused the breach will probably be fired and his supervisor reprimanded and if anybody goes to jail, it will probably be them and not any of the bureaucrats who sat back, gave the orders, failed to provide on-site supervision and then will duck the ultimate responsibility.

I guess I am just mad that this happened and that the EPA directly caused it. I am angry that they put all kinds of road blocks in the way of the mining community, yet they are incapable of avoiding catastrophe themselves. The sludge spilled contains heavy metals to include lead, cadmium, copper, arsenic, and a host of others. The lead alone was measured at 5720 parts per billion (ppb) and the acceptably safe level is considered to be only 50 ppb. That is the danger of these old mines. They have sat abandoned for decades, slowly filling with seep and ground water, collecting all kinds of stuff as they fill. We have known for a long time that they present a very difficult problem to mitigate. I think we all understand that. I believe that some of the large corporations who owned and worked some of these time bombs and who still operate in the mining industry today, have to step up to the plate and accept some responsibility for their current condition and provide some profit dollars for the necessary mitigation to render these sites safe. Will they do it..? Not likely in my opinion. And right now, the Bureau of Land Management (BLM) as well as the US Forest Service is looking to auction/extend leases of thousands of additional acres to the large oi and gas companies. In business, it is all about the profit margin. Moral responsibility doesn't seem to be very important in the world of business. Government and business have long been in bed together. It is all just so disappointing to me and I hope, to you as well. I expect we will be hearing of negative consequences to this incident for the next decade or so. And we small scale miners will ultimately find that it was all our fault.

Anyway, that is the view from here and I wish you all Good Luck in your search! And until we meet again, keep your sunny sides up and may the bottoms of your pans turn bright with that treasured 'Yaller Gold'!

#### The V.P. Corner by "Klondike" Mike



Well folks we are getting closer to the final areas that you can check out here in Colorado.

We started close to Denver and now we are moving out to our borders. Jamestown is in Central district. Nine miles northwest of Boulder there were many Area mines. Lefthand Creek, north of gold Hill, Bummers Gulch, Coon Trail, North Beaver

And South Boulder Creeks, southeast of Caribou contain placer gold. James Creek above Jamestown contains placer gold. Central Gulch, west of Jamestown contains placer gold.

Upper Fourmile Creek, northwest of Sugarloaf contains placer gold. It had a total production of 207,000 gold ounces. There are many area mines that produced gold in pyrite and telluride minerals. The Jamestown, Gold Hill and Ward area mines all produced lode gold.

<u>Ward</u> – Ward Colorado district is 9 – 13 miles northwest of Boulder. It covered 12 square Miles in headwaters of Lefthand and Fourmile Creeks. The old camps of Sunset and Copper Rock, more than 50 lode mines in the area, had a total production of 172,000 ounces of Lode gold. The Niwot and Columbia mines were the largest producers of lode gold. In east part of the district, many mines produced gold in tellurides.

<u>Garfield</u> The Monarch district is near Garfield at an elevation of 10,000 - 10,500 feet. The total production was between 15,000 - 20,000 ounces of by-product gold. The area mines in T49 and 50N, R6E, on old dumps there are gold showings. The Madonna Mine was a major producer of lode gold.

## **Prospecting/Mining Notes:** (mostly from the Denver Post, Internet and other wire services)

8-10-15 **EPA** Creates Biggest Mine Spill in Recent Colorado History: Environmental Protection Agency (EPA) workers working on the Gold King Mine near Silverton, inadvertently broke an earthen 'cork' resulting in a massive pollution spill of heavy metal waste into the Animas River. The spill is estimated at more than 3 million gallons at the time and is continuing to lead 500 gallons an hour into the pristine Animas River watershed. The water contains heavy metals such as lead, cadmium, copper and zinc and a host of other environmentally dangerous chemicals to include benzene and arsenic. The EPA issued an apology saying 'we are sorry for this unfortunate incident and accept full responsibility for what we have done'. (I thought the photo to the right pretty much says it all...JJ)







8-26-15 **World's Biggest Miner Posts Drop in Profits:** BHP Billiton, the world's biggest miner and based in Melbourne, Australia, reported an 86% drop in annual profit amid plummeting commodity prices. The company warned that that China's slowing economy would lead to further market volatility.

NOTE: (The recent spectacular drop in the DOW and NASDAQ in the last week has been a result of several factors, one of which is the closing of the China economy as well as the weakened European economy as a result of continued Greece problems. But analysts speculate that the American economy is doing well and that this may be no more than an expected market adjustment which has been long expected. Bottom line is that while the DOW drops, gold is apt to take a hit in the beginning but generally rebounds well when people begin mistrusting the US Dollar JJ)

## What is Mining?

**Machines:** Heavy machinery is used in mining to explore and develop sites, to remove and stockpile overburden, to



break and remove rocks of various hardness and toughness, to process the ore, and to carry out reclamation projects after the mine is closed. Bulldozers, drills, explosives and trucks are all necessary for excavating the land. In the case of placer mining, unconsolidated gravel, or alluvium, is fed into machinery consisting of a hopper and a shaking screen o



trommel which frees the desired minerals from the waste gravel. The minerals are then concentrated using sluices or jigs. The Bagger 288 (pictured at left) is a bucket wheel excavator used in strip mining. It is also the largest land vehicle of all time. A Bucyrus Erie 2570 dragline and CAT 797 haul truck (pictured below) at the North Antelope Rochelle opencut coal mine.

Large drills are used to sink shafts, excavate stopes, and obtain samples for analysis. Trams are used to transport miners, minerals and waste. Lifts carry miners into and out of mines, and move rock and ore out, and machinery in and out, of underground mines. Huge trucks, shovels and cranes are employed in surface mining to move large quantities of overburden and ore. Processing plants utilize large crushers, mills, reactors, roasters and other equipment to consolidate the mineral-rich material and extract the desired compounds and metals from the ore.



#### **Processing:**

*Main articles: mineral processing and extractive metallurgy.* Once the mineral is extracted, it is often then processed. The science of extractive metallurgy is a specialized area in the science of metallurgy that studies the extraction of valuable metals from their ores, especially through chemical or mechanical means.

Mineral processing (or mineral dressing) is a specialized area in the science of metallurgy that studies the mechanical means of crushing, grinding, and washing that enable the separation (extractive metallurgy) of valuable metals or minerals from their gangue (waste material). Processing of placer ore material consists of gravity-dependent methods of separation, such as sluice boxes. Only minor shaking or washing may be necessary to disaggregate (unclump) the sands or gravels before processing. Processing of ore from a lode mine, whether it is a surface or subsurface mine, requires that the rock ore be crushed and pulverized before extraction of the valuable minerals begins. After lode ore is crushed, recovery of the valuable minerals is done by one, or a combination of several, mechanical and chemical techniques.

Since most metals are present in ores as oxides or sulfides, the metal needs to be reduced to its metallic form. This can be accomplished through chemical means such as smelting or through electrolytic reduction, as in the case of aluminum Geometallurgy, combines the geologic sciences with extractive metallurgy and mining. (*More to follow next month*)

In light of the recent mine spill from one of Colorado's hundreds of abandoned mines, why not take some time out to learn a little bit more about the mining history of this state?




